

TERMS AND CONDITIONS

1. Entry requirements:
 - a. Entry is open to South Australian residents who are legal residents of Australia aged 16 years of age or over. Entrants under the age of 18 years require parental consent. The Promoters reserve the right to request the prize winner to provide parental consent in writing and evidence of residency prior to awarding the prize.
 - b. Entrants must be available:
 - i. For a two hour photo shoot with the Car Toys and Massive Audio Demo Car
 - ii. For Auto Salon on Saturday and Sunday, August 7th and 8th, 2010.
 - iii. To attend meetings, rehearsals and fittings in the week leading up to Auto Salon
 - iv. To attend a Car Toys Show Room Show Case of the Demo Car in December 2010
 - c. It is a condition of entry into this promotion that each entrant agrees that if they are shortlisted or win a prize in this promotion, they will comply at all times with any terms of participation in the photo shoot, the final stage and the winning prize, and the winner must comply with all directions provided by the Promoter.
2. Competition opens Tuesday June 1, 2010 and closes at midnight on June 20, 2010. **(Competition Period)**.
3. Instructions on how to enter and all prize details form part of the conditions of entry. By entering, entrants accept these conditions.

To enter the competition, entrants must during the Competition Period complete the application form and send in a still full length and close up photograph of themselves with their full name, address, age and telephone number via email. One entry per person, multiple entries are not acceptable.

 - a. Photographs must not contain any offensive or defamatory material.
 - b. Any computer images produced by Photoshop are not eligible to enter the competition.
 - c. Photographs must be previously unpublished.
 - d. Upon receipt of entries, they become the property of the Promoters and will not be returned to the entrants. Entrants should keep a copy of their entry.
6. If for any reason the Promoters are unable to publish or otherwise use a photograph submitted as part of this competition, that entry will be excluded and the entrant is not eligible to be awarded a prize.
